## TERMS AND CONDITIONS OF EZ-LINK MOTORING SERVICE (EZ-PAY) LUCKY DRAW "HIT THE SNOOZE BUTTON ON ERP"

## Terms and Conditions

- 1. These terms and conditions ("Terms and Conditions") shall apply to the EZ-Link Motoring service (EZ-Pay) Lucky Draw "Hit the Snooze Button on ERP" ("Lucky Draw") organised by EZ-Link Pte Ltd ("EZL").
- 2. By registering or taking part in this Lucky Draw, you agree to be bound by these Terms and Conditions and the decision(s) of EZL in relation to and in connection with this Lucky Draw.
- 3. Lucky Draw is applicable to Citibank Singapore and DBS/POSB Credit/Debit Card ("Qualified Card") members only.

  - b. Must be a newly registered vehicle on EZ-Link Motoring service (EZ-Pay) i.e. the customer must not have cancelled the EZ-Link Motoring service (EZ-Pay) for the participating vehicle in the last 12 months;
  - c. Registered vehicle must be active on the EZ-Link Motoring service (EZ-Pay) account as of 28<sup>th</sup> February 2021

  - a. EZL reserves the right to postpone the draw dates without any notice or liability to any party. The draw date as of the effective date of this Terms & Conditions shall be on the 1<sup>st</sup> March 2021.

Prizes not collected by 30 days after notification via email will be forfeited and organizer reserves the rights to give the prize to the reserved winner. The winner(s) must produce Identification document for verification to claim his/her prize within the stipulated dates.
