Terms and Conditions – Support local with your EZ-Link Wallet & Win (1 Nov – 31 Dec)

1. These terms and conditions ("Terms and Conditions") shall apply to the "Support local with your EZ-Link Wallet & Win" campaign organised by EZ-Link Pte Ltd.

2. Eligibility

This "Support local with your EZ-Link Wallet & Win" campaign is only open to registered EZ-Link Wallet users.

3. Qualifying Period, Campaign Mechanics and Lucky Draw Dates
