1. These terms and conditions ("Terms and Conditions") shall apply to the "Pay by Wallet Sign-up Campaign" organised by EZ-Link Pte Ltd.

### 2. Eligibility

This "Pay by Wallet Sign-up Campaign" is only open to registered EZ-Link Wallet users.

### 3. Qualifying Period, Campaign Mechanics and Lucky Draw Dates

- 3.1 Customers who sign up for EZ-Link's Pay by Wallet and/or spend transactions on the Pay by Wallet shall be eligible for the Cashback as well as entered into the Lucky Draw as set out in these Terms & Conditions.
