

Terms and Conditions for SimplyGo – EZ-Link Wallet with Mastercard and Trip.com Partnership on “Hotels 12% off” and “Flight 12% off” and “Attractions and Tours 12% off”

1. Promotion period for “Hotels 12% off” and “Flight 12% off”: **01 June 2025 to 31 August 2025**
2. Promotion period for “Attractions and Tours 12% off”: **01 July 2025 to 31 August 2025**
3. Eligible users: This promotion is only available to Trip.com members and EZ-Link Wallet with Mastercard users.
4. Discount for “Hotels 12% off” and “Flight 12% off” is valid for use on all Trip.com platforms from **01 June 2025 to 31 August 2025 or while stocks last**. Redemptions (upon a successful booking) are based on first-come, first-served basis.
5. Discount for “Attractions and Tours 12% off” is valid for use on all Trip.com platforms from **01 July 2025 to 31 August 2025**. Redemptions (upon a successful booking) are based on first-come, first-served basis.
 - a. Promo code “EZLWLTATT12” can be applied to each booking and each customer can only use the promo code a maximum of ten (10) times during the applicable promotion period.

9. EZ-Link Wallet with Mastercard users will need to enter and redeem the promo code “EZLWLTSTAY12” on Trip.com platforms for the discount to be applied during checkout.
10. EZ-Link Wallet with Mastercard users will need to enter and redeem the promo code “EZLWLTFly12” on Trip.com platforms for the discount to be applied during checkout.
11. EZ-Link Wallet with Mastercard users will need to enter and redeem the promo code “EZLWLTATT12” on Trip.com platforms for the discount to be applied during checkout.
