# 'Pretzel Catch' Game (July 2025) - Terms & Conditions ("T&Cs")

- 1. The game T&Cs pertaining to 'Pretzel Catch' ("Campaign") from 21 July 2025 to 31 August 2025 ("Campaign Period") are stated below.
- 2. The game platform will be accessible only to users of the SimplyGo App during the Campaign Period for the purpose of participating in the game. Following the end of the Campaign Period, the game platform will remain accessible to SimplyGo App users solely for the purpose of accessing their earned rewards and redeeming prizes until 31 October 2025. Any prizes not redeemed by 31 October 2025 will automatically be forfeited without further notice or liability to Chrisna Jenio Pte Ltd ("Auntie Anne's") or the SimplyGo App users. For the avoidance of doubt, all prizes that are listed in-app and managed solely within the game interface will be available for redemption upon being won.
- 3. By registering for or taking part in this Campaign, users agree to be bound by these T&Cs and the decision(s) of SimplyGo Pte. Ltd. ("SimplyGo") in relation to and in connection with this Campaign.

# 4. Eligibility and Game Play

- 4.1. To participate, users are to download the SimplyGo app. Thereafter, users are to start the game listed under the 'Rewards' tab and click on the 'EZ-Link Games' header in the SimplyGo app. Alternatively, users can also access the game via the floating icon within the app interface. Users will automatically be registered upon entering the game for the first time.
- 4.2. Users will have one (1) free play but will have the option to utilise their EZ-Link reward points to redeem additional game chances for subsequent rounds of the game. Each round of the game will be redeemable using sixty (60) EZ-Link reward points.
- 4.3. There are no limitations on the number of game chances that users can attain by utilising their EZ-Link reward points.

# 5. Prize Redemption

5.2 Please note that all prizes won through the Campaign can only be accessed via the game interface within the SimplyGo app, and not through the EZ-Link rewards catalogue or other redemption platforms. Only Golden Pretzel prize winners will receive a notification via email.

All other prizes (such as vouchers) will be listed in-app and managed solely within the game interface.

- Prizes won during the Campaign may be redeemed either in-store at participating Auntie Anne's outlets or at Auntie Anne's office, depending on the specific prize. Each prize will be tagged with a unique serial number which must be presented at the point of redemption. Winners must display the "Use Voucher Now?" game screen (as shown in the SimplyGo app) at the point of redemption, which includes the prize details and serial number, to validate their prize(s) won. #### **APPENDIX A**

### Golden Pretzel Prize: Auntie Anne's "1 Year's Worth of Pretzels" - Terms & Conditions

- 3.2 Pretzel flavours available for redemption are subject to in-store availability and may be subject to changes without prior notice.
- 3.3 Vouchers will be issued into the winner's Auntie Anne's Rewards account in four batches of 13 vouchers each, every 3 months.
- 3.4 The winner must make a one-time visit physically to the Auntie Anne's Singapore office before Friday, 31 October 2025 (during designated hours) to acknowledge the prize redemption and complete their Auntie Anne's Rewards account registration, if not already a member.
- 3.5 Unutilised voucher(s) will not be replaced or extended in terms of its validity. Any unutilised voucher(s) shall be deemed forfeited, and any request to extend such vouchers' validity shall not be entertained.
- 3.6 Vouchers are non-stackable, non-transferable, non-exchangeable, and not redeemable for cash.
- 3.7 Redemption is available at all Auntie Anne's outlets in Singapore except Jewel Changi.

Emails regarding any other prize types (such as vouchers) sent to this email address will not be entertained, responded to, or processed. All other prize redemptions must be carried out in accordance with the instructions provided within the SimplyGo app interface, and no further correspondence will be entertained for non-Golden Pretzel prizes or rewards.
