## 'Spin to Win' – Terms & Conditions ("T&Cs")

- 1. The game T&Cs pertaining to the 'Spin to Win' campaign ("Campaign") which runs from 1 August 2025 to 31 August 2025 ("Campaign Period") are stated below.
- 2. By registering for or taking part in this Campaign, users agree to be bound by these T&Cs and the decision(s) of SimplyGo Pte. Ltd. ("SimplyGo') in relation to and in connection with this Campaign.
